#### **Presenting your Bid**

- Have a presentation ready and be ready to answer questions. (SCM Ch 5, 1.3)
- The bids will be reviewed with the Competition Committee and shared with the full board.
- At the Competition Committee meeting the committee may want to ask questions. You will not present, but may be asked to answer questions that will assist with your presentation to the full board.
- At the plenary session, you will present your presentation to the full board. Times vary, so please be patient, flexible, and ready.

#### **Necessary Equipment**

- Registration system integration with Burble or dropzone management system
  - USPA created a registration page for host to use for consistency
    - Provide information that should be customized for your DZ
  - Host can provide registration link through their website
- Equipment needed to run the event(s) including scoring equipment (see Appendix C)
  - Events are:
    - Collegiate Sport Accuracy +Team
    - 2-Way VFS
    - 2-Way FS
    - 4-Way FS
    - 6-Way FS Speed
  - List of Items for judging (SCM Ch 5, 2.4)
  - The Host is responsible for providing a wind speedmeasuring device capable of displaying wind velocity in meters per second. (SCM Ch 1, 7.8.1)
  - The host must provide a video slate (or other suitable method) for FS and VFS events so that videographers can video their team number and round just before exit. (SCM Ch 1, 7.8.3)
  - A meet announcement board (or "DZ TV"), where an official clock is visible and official announcements including event holds, releases, scores, and protest results are posted, must be present. (SCM Ch 1, 7.8.4)
    - Printer and person to consistently print and post announcements
    - Scoring system for the entire event
    - Consider What's App for additional communication
  - What time frame does the provider guarantee videos and/or scores will remain after the event?
  - Additional timeframe and fees to have videos accessible?

#### Event Judges/Staff/Meet Officials

- Judges and Judge Fees (see Appendix A) (SCM Ch 1, 4.2 and Ch 5, 2.11)
  - Daily rates including travel days, travel, accommodations, meals (breakfast, lunch, and snacks, coffee, water), transportation to and from accommodations (SCM Ch 5, 2.11)
    - Judges can rent Turo cars and rideshare
      - Reimbursed by dropzone confirm with DZ/ person in charge of judge coordination for pricing
    - Get a list of volunteers to drive/shuttle
    - Some DZs have DZ cars and can share them
      - Coordinate flights and pickups on a schedule
    - If renting Air BNBs, each house should have a car
  - Accommodations can be Airbnbs, hotels, etc (can be a shared room for 2 as long as separate beds)
    - For Airbnbs it is suggested same discipline for the same timeframe and schedule
    - If judges are judging multiple events, align with other judges with similar schedules
  - Travel days are 1 day before and 1 day after the competition scheduled dates
  - Judges are paid for scheduled competition days, regardless of weather or completing the competition early
  - Video Controller (SCM Ch 1, 4.5)
- Meet Director (SCM Ch 1, 4.1 Meet Director) who nominates Chief Judges (SCM Ch 1, 4.2) who selects the event judge and judge staff (SCM Ch 1, 4.2.2, 4.2.4)
- Volunteers (see Appendix A)
- Video Pool (SCM Ch 7, 5.2)
  - Collegiates: Panel of videographers for FS and VFS (SCM Ch 5, 2.13.7)
  - Pack jobs, meals, accommodations, agree if volunteers or paid
- Additional Staff
  - Consider registration, manifest, payments, packers, fuelers, food services, cleaning and trash along with additional hours of operation (SCM Ch 5, 2.13.2)
  - Meet management is to provide sufficient staff (normally one or two persons) to make up the scoring and recording section of the judging staff (SCM Ch 1, 7.8.2)
  - Gear tags and reserve checks
  - S&TA on site daily
  - Required additional staff for events (See Appendix A)

#### **Things To Consider**

- Ask for past winning bids by year through USPA, Director of Competition (SCM Ch 5, 1.2.6)
- Dates: Collegiates are December 28-January 2 (SCM Ch 7, 2.5.1)
- Controller Fees per diem and housing (SCM Ch 5, Appendix B, Host Responsibilities #7)
- Aircraft
  - Exit Altitudes and Airspace (see Appendix E) (SCM Ch 1, 8.2; Ch 5, 2.1 and 2.10)
  - Maximum number of competitors per pass (Appendix E)
  - Rejumps and Go Arounds (SCM Ch 1, 8.2.2.3, 8.2.3.1, 8.2.3.2)
  - Tie Breaks (See Appendix G)
    - This could be for 1 person or a small group, so consider additional operational costs.
  - Accuracy Landing WDI dropped from plane (SCM Ch 8, 1.4)
  - Where to get additional aircraft?
    - Contact info for possible rentals, etc (SDC, XP, SDAZ, SDMW)
  - Have an A&P mechanic on hand to handle anything that arises is super helpful

#### • Facilities (SCM Ch 5, 2.2, 2.3)

- Are additional tents needed?
- Are porta potties needed?
- Creeper space for FS teams
- Rooms for judging panels and scoring
- Sanction Fees (SCM Ch 1, 8.8.4; Ch 5, 2.9) (See Appendix D)
- Medals fees and appliques (see Appendix B) (SCM Ch 5, Appendix B, Host Responsibilities #11)
  - Guest Medals (SCM Ch 1, 8.10.2)
  - Current pricing (Sept 2023) for medals + backing = \$10 each
  - Most Competitive Collegiate Skydiver
- Performance Bond (SCM Ch 5, 2.12 and Appendix B #6, Host Responsibilities)
- Internet and Wi-Fi throughout the DZ
- Speaker system to reach entire DZ (SCM Ch 5, 2.13.1)
- Packers and large packing area
- Portable Ground to Air Radios (SCM Ch 5, 2.13.5)
- Ground to Ground Radios (SCM Ch 5, 2.13.6)
- Awards ceremonies, banquet, and social events (SCM Ch 5, 2.13.3)
- Refund Policy for jumps (SCM Ch 1, 3.4)
- Creating a logo (SCM Ch 5, Appendix B, Host Responsibilities #13)
- Enhancements or extras provided with registration, such as t-shirts, etc (SCM Ch 5, 2.7)

#### **Appendix G: Tie Breaker Procedures**

Discipline	Excerpt
Collegiates	<ul> <li>12.1. General</li> <li>12.1.1 The winners of an event are determined by combining all scores earned in completed rounds of the event.</li> <li>12.1.2 In the case of a tie in the top three places, one jump-off round will be conducted.</li> <li>12.1.3 If a tie still occurs, the competitor with the best score in any one round obtains the higher place.</li> <li>12.1.4 If a tie still occurs, the competitor with the best score, starting with the last completed round and continuing in reverse order, round by round until the tie is broken, obtains the higher place.</li> <li>12.1.5 If a tie still occurs, the competitors concerned shall be declared co-medalists.</li> </ul>
