AN IMPORTANT NOTICE TO USPA MEMBERS REGARDING

A STATEMENT OF PROXY



ollowing are photographs, candidate profiles and biographies for those who have offered to serve a three-year term on USPA's Board of Directors beginning in March 2025. It is your responsibility as a USPA member to vote for those you feel are best qualified to represent you.

Candidates were required to complete a standard biographical form and were invited to submit personal statements (limited to 250 words) describing their qualifications and their intentions if elected. These statements are printed along with the candidates' photographs and skydiving histories, as provided by them. Statements concluding with "- - -" were truncated to meet the 250-word limit.

THE BOARD OF DIRECTORS

USPA's Board has 22 elected members, eight of whom are national directors elected by the entire USPA membership, and 14 of whom are regional directors, elected by the members from the regions where they reside. When seated on the board, regional and national directors have equal authority.

National Director Nominees. You may vote for up to eight nominees for national director. You may vote for those whose names appear on the official ballot, or you may write in a candidate or candidates who do not appear on the ballot. The eight persons receiving the highest number of votes will be elected as national directors for the 2025-2027 term.

Regional Director Nominees. You may vote for one regional director candidate, and he or she must reside in your region, as established by your address on file at USPA. A regional director is the direct representative of the USPA members in that particular region. Some regions may have only one candidate, however, you may cast a write-in vote for someone who does not appear on the ballot, as long as he or she resides in your region.

USPA members who maintain an address outside of the United States may vote for any one eligible person as a regional director in any region.

VOTING PROCEDURES

Please read the information about each candidate carefully and study the instructions for voting.

Only current, regular members (annual and lifetime members, but not temporary members) are eligible to vote. Ballots must be in the approved format and received on or before the deadline. You may vote either by paper ballot or electronically.

Electronic Voting. Beginning October 1, members may visit uspa.org/election to view the online ballot and vote.

Also around October 1, current members with a valid email address on file at USPA Headquarters should receive an email from USPA. To ensure delivery, members are encouraged to add uspa.org to their list of approved contacts (sometimes referred to as a whitelist). The email will provide instructions on how to record your vote. There will be occasional email reminders from USPA until a vote is recorded or until the end of the election.

If you are a current member but do not receive an email, you may still log in to your USPA profile, use the provided *Parachutist* ballot or the downloadable ballot from uspa.org/ballot.

Paper Ballot Voting. Fill out the information on the ballot that appears on page 43, or download one from uspa.org/ballot. Ballots containing more than eight national director votes or more than one regional director vote will be disqualified. Ballots are valid only if they are individually marked and signed in the voter's original handwriting. Faxed or emailed ballots are not acceptable. You may vote any time after receipt of your ballot by detaching it from the magazine, indicating your selections and following the instructions for its return.

Members may vote one time only. If more than one ballot is cast, the first ballot received (by any method) will be the one counted. USPA Headquarters must receive all paper ballots or electronic votes no later than 5 p.m. EDT, Thursday, October 31, 2024.

New directors will be seated at the first board meeting of 2025, to be held March 15-17 in Daytona Beach, Florida. New USPA officers for the 2025-2027 term will be elected by the full board at this meeting.

EDWARD SCOTT (incumbent) Taylors, South Carolina

"I campaigned last time on the idea of reducing the number of board members and cutting board expenses. Apart from Luke Aikins, the idea received no support among the board and was dismissed. So, I turned my attention to increasing board transparency and membership engagement. I proposed two motions, which were both adopted. One requires the Executive Committee, which can make decisions in between board meetings, to fully disseminate their decisions within seven days instead of at the next board meeting. The other is to solicit board agenda items 60 days in advance, including from among the membership, and to publish the board agenda earlier (30 days instead of just two weeks), allowing more preparation.

I ask for your vote so I can apply my 24 years of experience working for USPA (11 as director of government relations and 13 as executive director) to the most consequential challenge we face. The FAA Reauthorization Bill that became law now requires the FAA to form a working group to consider imposing more regulations on skydiving aircraft and on jump pilots. While we should always focus on these areas, the greatly improved jump-plane-accident record argues against more burdensome and costly FAA requirements. I can help guide USPA's response to these threats and ensure we avoid costs that will increase the price of jumps, while maintaining our impressive level

If elected, this will be my last term on the board, as I intend to term limit myself."

3. Relocating USPA Headquarters to Florida: Moving from Fredericksburg, Virginia, one of the most expensive towns in the U.S., to Florida will reduce administrative costs. This relocation will also place USPA closer to a significant skydiving community, enhancing transparency and operational efficiency while potentially lowering membership dues.

I am committed to improving the USPA's global reach, operational effectiveness and furthering the conversation around the TI medical issue. I respectfully ask for your vote and support to bring these changes to fruition."

USPA BOARD OF DIRECTORS

On the following page is an official ballot for the election of the 2025-2027 USPA Board of Directors. In this election, the USPA membership will elect 22 directors who will serve for three years.

Only current, regular members (annual and lifetime members, but not temporary members) are eligible to vote, and each member may vote only once. USPA members who do not reside in the U.S. may vote for any one eligible person as a regional director and up to eight national directors.

HOW TO VOTE


National Director-You may vote for as many as eight USPA National Director candidates by marking your ballot with an "X" in the column next to the name of each candidate chosen. You may vote for fewer than eight candidates, but voting for more than eight will invalidate that section of your ballot. You may also write in the names of any candidate(s) not listed, but each write-in vote counts as one of the eight allowed.

Regional Director-You may vote for only one USPA Regional Director candidate, and he or she must reside in your region, as established by your address on file at USPA. The map below shows a regional breakdown by the first three digits of each zip code. Mark your ballot with an "X" in the column next to the candidate's name. You may also write in the name of any candidate for regional director not listed on the ballot, but that person must reside in your region. Voting for more than one candidate or voting for candidates outside of your region will invalidate that section of your ballot. Mark your selection clearly, and be sure the name of any write-in candidate is legible and spelled correctly.

THE DEADLINE

Paper ballots must be received at USPA Headquarters, 5401 Southpoint Centre Blvd., Fredericksburg, VA 22407, no later than 5 p.m. EDT October 31, 2024. Any ballots received after this date will be marked invalid.

Each paper ballot must be marked and signed by the voter in original handwriting. Although photocopies of this ballot are acceptable, each must still be marked and signed by the voting member. Paper ballots that are faxed, electronically transmitted or pre-marked will be declared invalid. Mail your ballot in today. Be counted. Vote!

AN IMPORTANT NOTICE TO USPA MEMBERS REGARDING ASSIGNING A PROXY

A Call for the Meeting and a Notice to Amend

n Thursday, March 13 at the Hilton Daytona Beach Ocean Front Resort, 100 N. Atlantic Ave, Daytona Beach, FL 32118, USPA will hold an annual general membership meeting. All members in good standing are invited and urged to attend. On the agenda are two questions, one regarding voting rights in regional director elections and the other requiring those running for the board to have U.S. citizenship or residency. If you cannot attend, you are urged to have a proxy represent you at the meeting.

Like all associations, USPA has a set of self-developed bylaws that codify certain aspects of how the association runs and how it conducts elections, including who can vote on or run for seats on the board. As is also common, certain parts of USPA's bylaws are subject to change by a two-thirds majority of the board, while other parts, specifically items dealing with board elections, require a quorum of the membership at the general membership meeting to make changes. Getting a quorum of USPA members (specified by the bylaws as 10% of the membership) at the meetings is nearly impossible without a proxy effort.

To meet the quorum requirement of 10%, approximately 4,200 members will need to be present or represented by proxy. A proxy is not technically a vote. Rather, it is an authorization a member gives to another member to vote on their behalf. A member may assign their proxy to any member in good standing who will be present at the meeting. Typically, in proxy solicitations, the proxy is given to an officer of the corporation in order to facilitate the validating and counting of proxies. For this meeting, the secretary of the USPA Board of Directors has been selected as the person named on the proposed proxy statement.

PROCEDURE

October 1-31, members may visit uspa.org/election, which will take them to both the USPA Board of Directors election ballot and the proxy statement containing two questions. Around October 1, members with a valid email address on file will also receive an email from USPA that will provide instructions on how to record board votes and submit the proxy. To submit a proxy electronically and have that proxy count toward the quorum, a member may choose yes, no or abstain on the proxy form. A member may also choose to submit their proxy later (in person at the meeting or by mail, fax or email) or decline submitting a proxy by choosing "skip this proxy vote."

From now until any time prior to the meeting, members may also submit their proxy statements by mail, email or fax by

filling out the statement on the previous page of this issue or downloading it from uspa.org/proxy. Members may also revoke a proxy at any time prior to its exercise at the annual meeting by executing a subsequent proxy in writing and sending it to USPA by mail, email or fax or by voting in person at the annual meeting. Written proxies are valid only if they are individually marked and signed in the member's original handwriting and sent to USPA by mail to 5401 Southpoint Centre Blvd, Fredericksburg, VA 22407; by fax to (540) 604-9741; or by scanning and emailing to uspa@uspa.org.

Members may submit proxies at any time but they must be received prior to the meeting. For the proxy to be valid, the person signing the statement or submitting it electronically must be an individual regular member (annual or lifetime member but not temporary member) of USPA on the date of record, which is established as March 12, 2024.

PROPOSED CHANGES

Voting in Regional Director Elections

This bylaw change would adjust voting rights in regional director elections. Currently, members who reside outside the U.S. are permitted to vote for any one regional director. Regional directors are intended to represent and be voted in by members who reside in that region. This change would remove the ability for members who reside outside the U.S. from voting for a USPA Regional Director and influencing an election in a region in which they do not reside. Members residing outside the U.S. will continue to have voting eligibility for all national director seats.

Over recent years, USPA has seen growth in the volume of USPA members residing outside the U.S. USPA has and intends to continue working with federations, drop zones and skydivers outside the U.S. in order to make memberships, licensing, credentials and other USPA benefits available to those outside the U.S. in an effort to grow the sport of skydiving worldwide. However, USPA's priority must maintain its domestic efforts and ensure that residents of a region elect their regional representation.

Board Candidate Qualifications

This proxy vote would require those running for positions on the USPA Board to hold a U.S. citizenship or reside in the U.S. One of USPA's core functions is working to ensure skydiving's rightful place on airports and in the U.S. airspace system. Passage of this bylaw change would ensure the USPA Board makeup consists of those who have direct ties to domestic interests in the U.S.
